3. The Revised Tariff Components attached as Annex-I are to be notified in the official Gazette.



DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR HUANENG SHANDONG RUYI (PAKISTAN) ENERGY PRIVATE LIMITED.

1. Pursuant to the Decision of the Authority dated March 31, 2015 in the matter of approval of upfront coal tariff for 2x660 MW coal power plant of Huaneng Shandong Ruyi (Pakistan) Energy Private Limited (hereafter "HSRPEL") and decision of the Authority dated January 17, 2019 in the matter of tariff adjustment at Commercial Operation Date (COD, the relevant tariff components in respect of October-December 2019 quarter has been revised on account of US CPI, CPI (General), exchange rate, KIBOR, LIBOR, coal price(s) and coal calorific value(s) variation.
