DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT OF TARIFF FOR LARAIB ENERGY LIMITED

Pursuant to the decision of the Authority dated March 4, 2015 in the Matter of Interim Relief to Laraib Energy ltd (Case No. NEPRA/TRF-100/2009) and decision of the Authority dated 14th December, 2009 in the matter of procurement of power by NTDC from Laraib energy Limited (Case No NEPRA/TRF-100/2009), the tariff of Laraib Energy Limited in respect of quarterly adjustments for the period from April, 2013 to March, 2015 has been revised on account of Kibor/Libor and exchange rate variation in accordance with the requisite indexation/adjustment mechanisms stipulated in the above referred decisions of the Authority.
