#### Subject: Decision of the Authority in the Matter of Adjustment of Calorific Value for Liberty Power Tech Ltd. (Case No. NEPRA/TRF-89/LPTL-2007)

Please find enclosed herewith the decision of the Authority along with Annex-I (03 pages) in the matter of adjustment of Calorific Value for the period July 2014 to June 2015 in respect of Liberty Power Tech Ltd. in Case No. NEPRA/TRF-89/LPTL-2007.

## DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF CALORIFIC VALUE FOR LIBERTY POWR TECH LIMITED (LPTL)

- 1. According to the decision of the Authority dated 3<sup>rd</sup> June 2011 in the matter of calorific value adjustment mechanism, the calorific value (CV) of furnace oil is subject to adjustment on actual basis. The following was decided by the Authority:
  - i) to fix 18364 Btu/lb as reference CV with no adjustment below the minimum limit agreed in the FSA.
  - ii) to direct the IPPs to maintain and submit, annually a detailed record of consignment wise CV of the oil received and consumed by IPPs for power generation for its adjustment with respect to reference calorific value duly supported with the copies of test reports certified by the fuel supplier.
- 2. Liberty Power Tech Limited (LPTL) vide letter dated October 07, 2015, submitted its required information along with supplier's certificates of calorific value. On the basis thereof, LPTL worked out minus Rs. 34,640,563/-, payable by LPTL to power purchaser, as adjustment on account of variation in calorific for the FY 2014-15.
- 3. The information was analyzed in the light of the evidence provided by LPTL. Based thereon, the actual amount payable by LPTL to power purchaser works out to be minus Rs. 34,704,947/-. The major reason for the difference of Rs. 64,384/- is due to approved Fuel Cost Component for the month of February, 2015 included by LPTL as Rs. 9.2674/kWh instead of Rs. 9.2553/kWh. The Authority has decided to approve Rs. 34,704,947/- payable by LPTL, on account of adjustment of actual monthly average CV against the reference CV of 18,364 Btu/lb for the period July 2014 to June 2015. The detailed calculations are attached as Annex-I.

### Order

4. The Central Power Purchasing Agency is directed to deduct/adjust **Rs. 34,704,947/**against the outstanding amount of LPTL on account of adjustment of calorific value for the period July 2014 to June 2015.
