
*Revised Insurance premium works out to be 0.583 % of the approved EPC cost.


3. CPPA-G to ensure that all the payments are consistent with tariff determination.

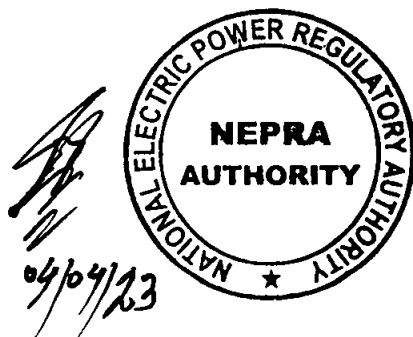


