**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR  
NATIONAL POWER PARKS MANAGEMENT COMPANY (PRIVATE) LIMITED FOR ITS POWER  
PROJECT AT BALLOKI.**


Pursuant to the Authority's decision dated 9<sup>th</sup> August 2016 in the matter of Tariff Petition filed by National Power Parks Management Company (Private) Limited for its Power Project at Balloki (hereinafter "NPPMCL-Balloki"), the fuel cost components on combined cycle operations have been adjusted for variation in RLNG price. The revision has been made on provisional basis as per OGRA's determination of provisional RLNG weighted average price for SNGPL dated October 9, 2019, and final fuel cost component(s) shall be determined after notification of final RLNG price by OGRA and submission of fuel invoice(s) by NPPMCL. The revised fuel cost components on combined cycle operations on RLNG indicated hereunder shall be immediately applicable on unit delivered basis:

W.e.f. October 1, 2019	9.2564
W.e.f. October 9, 2019	9.2361
W.e.f. October 16, 2019	9.2257
W.e.f. October 24, 2019	9.2257


2. In case RLNG price is not changed or not determined by the OGRA for the next period/month, Fuel Cost Component effective from 24<sup>th</sup> October 2019 shall remain applicable.
3. The above referred revised fuel cost components attached as **Annex-I** are to be notified in the official gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
4. CPPA(G) to ensure that all payments are consistent with tariff determination.



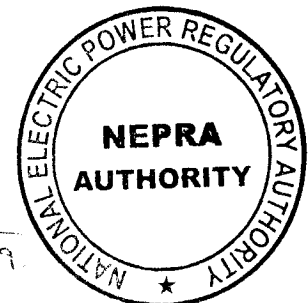

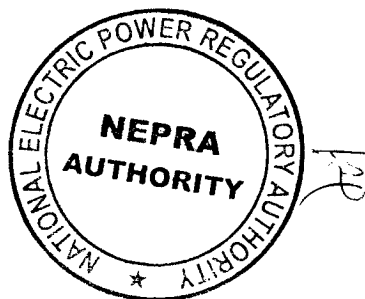
