DECISION OF THE AUTHORITY UNDER NEPRA (REVIEW PROCEDURE) REGULATIONS, 2009 REGARDING DECISION OF THE AUTHORITY IN THE MATTER OF PETITION FILED BY NPPMCL FOR MODIFICATION IN THE DETERMINATION DATED MAY 20, 2020 1,223.106 MW (GROSS) POWER PROJECT AT BALLOKI, DISTRICT KASUR

- The variable O&M (foreign) component on HSD in the subject decision dated Feb 3, 2025 is erroneously calculated on the basis of RLNG net capacity of 1,205.046 MW instead of HSD net capacity of 1,095.045 MW, which needs to be rectified.
- 2. Accordingly, in pursuance of Section 7(2)(g) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 read with Regulation 3 of NEPRA (Review Procedure) Regulations, 2009, the approved variable O&M (foreign) component on HSD of Rs. 0.1741/kWh shall stand replaced with Rs. 0.1919/kWh in the Tables under Para 18.8 and Order para I of the subject decision dated Feb 3, 2025.
- 3. The above decision of the Authority is to be notified in the Official Gazette along with decision dated February 3, 2025 in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
