DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR NATIONAL POWER PARKS MANAGEMENT COMPANY (PRIVATE) LIMITED FOR ITS POWER PROJECT AT HAVELI BAHADUR SHAH.

Pursuant to the Authority's decision dated 9th August 2016 in the matter of Tariff Petition filled by National Power Parks Management Company (Private) Limited (hereinafter "NPPMCL") for its Power Project at Haveli Bahadur Shah for determination of Generation Tariff on RLNG/HSD and Authority's decision dated 24th October 2018 in the matter of HSD testing on combined cycle in the post synchronization period before Commercial Operation Date (COD), the fuel portion of energy charge part of tariff has been adjusted for variation in HSD prices. The revised energy charge part of NPPMCL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:
