**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT
ON HSD FOR JANUARY 16, 2022 FOR NATIONAL POWER PARKS MANAGEMENT
COMPANY (PRIVATE) LIMITED FOR ITS POWER PROJECT AT HAVELI
BAHADAR SHAH**


Pursuant to the Authority's decision dated February 19, 2020 in the matter of tariff of tariff adjustments at Commercial Operation Date (COD) of National Power Parks Management Company (Private) Limited for its Power Project at Haveli Bahadar Shah (hereinafter "NPPMCL-HBS") and decision of the Authority dated May 20, 2020 notified vide S.R.O. No.484(I)/2021 in the matter of Review Motion against the COD decision, the fuel portion of energy charge part of tariff is required to be adjusted for variation of HSD price(s). Based on revised HSD price(s), the fuel cost components have been adjusted and indicated hereunder which shall be immediately applicable to the units delivered basis:



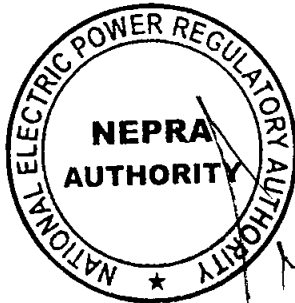
