Please find enclosed herewith the subject decision of the Authority along with revised schedule of tariff at **Annex-I** (03 pages) regarding annual adjustment of insurance component of capacity charge part of tariff on account of Actual Insurance Premium for the period **July 01, 2023 to June 30, 2024** in respect of National Power Parks Management Company (Private) Limited's Haveli Bahadar Shah Power Project in Case No. NEPRA/TRF-358/NPPMCL-2016.

2. ## ANNUAL ADJUSTMENT OF INSURANCE COMPONENT FOR THE PERIOD JULY 1 2023 TO JUNE 30. 2024 OF NATIONAL POWER PARKS MANAGEMENT COMPANY (PRIVATE) LIMITED FOR ITS POWER PROJECT AT HAVELI BAHADAR SHAH.

Pursuant to the Authority's decision dated May 20, 2020 notified vide S.R.O. No. 484(1)/2021 in the matter of Review Motion against the COD decision, the insurance component of tariff is subject to annual adjustment as per actual cost with maximum of 1% of EPC cost. National Power Parks Management Company (Private) Limited-Haveli Bahadar Shah (hereinafter refer as "NPPMCL-HBS") requested to revise the insurance components of Rs. 0.2367/kW/h & Rs. 0.2699/kW/h on the basis of insurance premium amount of Rs. 2,518,829,628/- for RLNG & HSD, respectively, for the period of July 1, 2023 to June 30, 2024. NPPMCL-HBS in support provided copies of premium invoices and payment evidences. The details of insurance premium paid are provided hereunder:

- 2. As per the approved mechanism, NPPMCL-HBS is allowed to adjust its insurance component annually on the basis of Actual Premium or 1% of the EPC cost at exchange rate prevailing on the 1<sup>st</sup> day of the insurance coverage period, whichever is lower. 1% of the EPC cost is equal to US 5.837 million. On the basis of prevailing exchange rate of PKR 287.10/US\$ for the period from July 1, 2023 to June 30, 2024, the maximum limit for insurance cost works out PKR 1,675,814,184.
- 3. The requested insurance premiums works out 1.50% of the approved EPC cost for the period from July 1, 2023 to June 30, 2024 and is higher than the approved limit of insurance cost. Therefore, as per the approved mechanism insurance premium as per capped limit is considered for adjusted insurance components.
- 4. The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Based the information/documents provided by NPPMCL-HBS and in accordance with the Schedule VIII of Power Purchase Agreement, the insurance component of capacity charge part of tariff for the insurance coverage period of July 1, 2023 to June 30, 2024 (366 days) has been revised on the insurance premium of Rs. 1,675,814,184."

5. The revised insurance components of capacity charge part of tariff indicated hereunder shall be immediately applicable:
