DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR NATIONAL POWER PARKS MANAGEMENT COMPANY (PRIVATE) LIMITED FOR ITS POWER PROJECT AT HAVELI BAHADAR SHAH.

Pursuant to the decision of the Authority dated August 09, 2016 in the matter of Generation Tariff for National Power Parks Management Company (Private) Limited for its Power Project At Haveli Bahadar Shah on simple cycle operation, the fixed O&M, variable O&M and cost of working capital components of tariff in respect of July-September 2017 quarter has been revised on account of US CPI, CPI (General), exchange rate and KIBOR variation in accordance with the requisite indexation/adjustment mechanisms stipulated in the decision of the Authority. The revised tariff indicated hereunder shall be immediately applicable:
