
**DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT
OF TARIFF FOR NISHAT CHUNIAN POWER LIMITED**


Pursuant to the decisions of the Authority dated 20th December 2012 in the matter of change of index from WPI (Manufactures) to CPI (General) in the case of Nishat Chunian Power Limited (NCPL), the variable and fixed O&M components of tariff of NCPL in respect of October-December 2011 to October-December 2012 quarters have been revised on account of CPI (General) in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority. The revised tariff indicated hereunder shall be immediately applicable to the units delivered during the quarters:



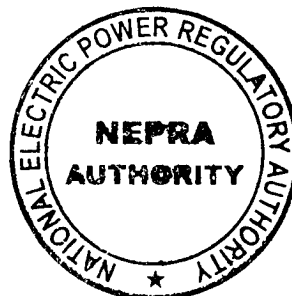


