Subject: **Decision of the Authority in the matter of Adjustment in Insurance Component of Tariff for the Period of July 01, 2025 to June 30, 2026 for Nishat Chunian Power Limited**

Dear Sir,

Please find enclosed herewith subject the Decision of the Authority along with **Annex-I** (total 02 pages) regarding adjustment in insurance component of Nishat Chunian Power Limited tariff on account of Actual Insurance Premium for the period **July 01, 2025 to June 30, 2026** in Case No. NEPRA/TRF-70/NCPL-2007.

2. The Decision is being intimated to the Federal Government for the purpose of notification in the official Gazette pursuant to Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 within 30 Calendar days from the intimation of this Decision. In the event the Federal Government fails to notify the subject tariff Decision within the time period specified in Section 31(7), then the Authority shall notify the same in the official Gazette pursuant to Section 31(7) of NEPRA Act.

**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF TARIFF FOR THE PERIOD OF JULY 1, 2025 TO JUNE 30, 2026 FOR NISHAT CHUNIAN POWER LIMITED.**

- Pursuant to the decision of the Authority dated December 31, 2010 in the matter of adjustment at Commercial Operation Date (COD) in the case of Nishat Chunian Power Limited (NCPL) and the decision of the Authority dated May 27, 2025 in the matter of joint application filed by CPPA-G and NCPL for reduction in tariff components notified vide S.R.O. No. 1323(I)/2025 on July 14, 2025, the insurance component of tariff is subject to adjustment as per actual annually. NCPL requested to approve insurance component of Rs. 0.2770/kW/h for the period July 1, 2025 to June 30, 2026. NCPL in support of its request submitted copies of insurance policies, premium calculations, no claim bonus and payment evidences of previous year. The details of requested insurance cost net of Sales Tax on Services is as under:



- Schedule VIII of the Power Purchase Agreement (PPA) does not provide provision for electronic equipment & machinery tools and cash and insurances, therefore, the same has not been considered.
- After excluding the above-mentioned insurance costs, the net admissible insurance cost amounts to Rs. 524,706,569.00, which works out to 0.99% of EPC cost at the exchange rate of Rs. 284.10/US\$. However, the Authority through its decision dated May 27, 2025 revised the insurance adjustment mechanism, wherein, NCPL is allowed to adjust its insurance component annually on the basis of actual premium or 0.90% of EPC cost, whichever is lower. Accordingly, 0.90% of the EPC cost i.e. US\$ 185,810,000.00 translates into Rs. 475,097,589.00 at the prevailing exchange rate and same has been allowed.
- The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereinafter called as the decision of Authority in the matter:

“Based on information and documentary evidence(s) provided by NCPL and in accordance with Schedule VIII of Power Purchase Agreement, the insurance component of capacity charge part of tariff has been revised to Rs. 0.2770/kW/h for the coverage period of July 1, 2025 to June 30, 2026 on the basis of net insurance cost of Rs. 475,097,589.00.”

- The above decision of the Authority along with revised tariff schedule attached as **Annex-I** are to be notified in the official Gazette, in accordance with the provisions of section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997).
- CPPA-G to ensure that all payments are consistent with the tariff determination(s).
