3. Please note that only revised schedule of tariff is required to be notified in the official Gazette.

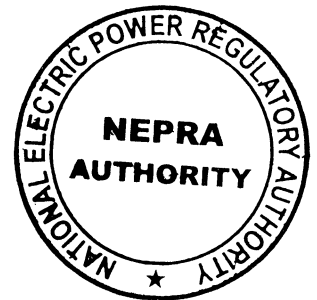

**DECISION OF THE AUTHORITY IN THE MATTER OF
FUEL PRICE ADJUSTMENT FOR NISHAT CHUNIAN POWER LTD. (NCPL)
(CASE NO. NEPRA/TRF-70/NCPL-2007)**


Pursuant to Para 24(VIII) of the Authority's determination in case No. NEPRA/TRF-70/NCPL-2007 regarding Nishat Chunian Power Limited (hereinafter "NCPL") dated 13th April 2007, read with Authority's decision dated 4th March 2009, based on information submitted by NCPL, the fuel portion of the energy charge part of NCPL's tariff has been adjusted for variation in furnace oil prices for the month of March 2010. The revised energy charge part of NCPL's tariff relating to fuel indicated hereunder shall be immediately applicable to the units delivered during the month:

2.	16 th to 31 st March, 2010	9.1211




