3. Please note that only revised schedule of tariff (Annex-I) is required to be notified in the official Gazette.

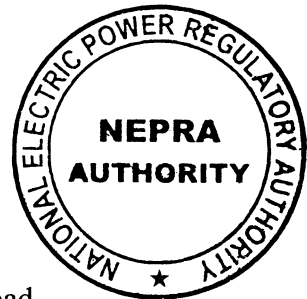


**DECISION OF THE AUTHORITY IN THE MATTER OF

Pursuant to Para 24(VIII) of the Authority's determination in case No. NEPRA/TRF-71/NPL-2007 regarding Nishat Power Limited (hereinafter "NPL") dated 13th April 2007, read with Authority's decision dated 4th March 2009, based on information submitted by NPL, the fuel portion of the energy charge part of NPL's tariff has been adjusted for variation in furnace oil prices for the month of February 2009.
