DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR NISHAT POWER LIMITED

Pursuant to Para 14(III)C of the Authority's decisions dated 27° August 2010 & October 15, 2010 in case No. NEPRA/TRF-71/NPL-2007 regarding Nishat Power Limited (hereinafter "NPL"), based on information submitted by NPL, the fuel portion of the energy charge part of NPL's tariff has been adjusted for variation in furnace oil prices for the month of June 2011. The revised energy charge part of NPL's tariff relating to fuel indicated hereunder shall be immediately applicable to the units delivered during the month:

While considering the fuel price adjustment, the Authority noted that the price (Rs. 64,322.72/M. Ton) of RFO supplied by Rawal Oil Traders, the alternate/additional fuel supplier, in the 2nd fortnight of May 2011 is higher by Rs. 172.67/M. Ton than the price (Rs. 64,150.05/M. Ton) of RFO indicated by Shell Pakistan Limited, the main fuel supplier, for Ex-Parco supplies at NPL plant. In the opinion of the Authority, the difference in price is not justified and cannot be passed on to the consumers. Accordingly, the weighted average fuel price has been adjusted to the extent of Rs. 172.67/M. Ton for 3,980.36 M. Tons of RFO for Ex-Parco supplies by Rawal Oil Traders. The revised fuel cost component works out Rs. 12.7414/kWh against Rs. 12.7485/kWh as requested by NPL.

The above referred revised fuel cost components attached as **Annex-I** requires to be notified in the official gazette in pursuance of the Amendment in Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
