<u>Decision of the Authority in the Matter of Adjustment in Insurance Component of</u> <u>Capacity Charge Part of Tariff for Nishat Power Limited (NPL)</u>

1. Pursuant to the decision of the Authority dated March 22, 2011 in the matter of Motion for Leave for Review filed by NPL against the decision of the Authority at COD dated 15th October 2010 regarding Nishat Power Limited (NPL), on the basis of information provided by NPL, the insurance component of capacity charge part of tariff for the period 1st July 2017 to 30th June 2018 has been revised on the basis of insurance premium as per details provided hereunder:

- 2. The Schedule-VIII of PPA does not provide for marine insurance during operational phase of the project, therefore, marine insurance has not been considered.
- 3. The Authority vide its decision No. NEPRA/TRF-71/NPL-2007 dated September 11, 2013, decided to consider only those insurances which are specifically mentioned in the Schedule VIII of the PPA. Accordingly, the health insurance, head office assets insurance and cash in transit and in safe insurance, are not being allowed. Accordingly, the Authority considered Rs. 165,965,029/- as insurance premium for the period July 1, 2017 to June 30, 2018.
- 4. The revised insurance component of capacity charge part of tariff has been calculated as indicated hereunder which shall be immediately applicable:
