4. Please note that only revised schedule of tariff is required to be notified in the official Gazette.

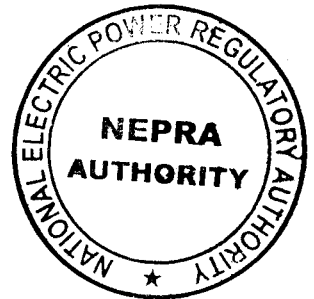





**DECISION OF THE AUTHORITY IN THE MATTER OF  
INTERIM FUEL PRICE ADJUSTMENT FOR NISHAT POWER LTD. (NPL)  
(CASE NO. NEPRA/TRF-71/NPL-2007)**


The Authority has considered the request of Nishat Power Limited (NPL) relating to fuel cost adjustment of its tariff on account of revision in fuel prices for the month of December, 2009. The Authority has observed that some of the assumptions prescribed in the notified mechanism are no longer applicable, therefore, the mechanism needs to be modified/updated. Since the requisite modification/revision would take some time, therefore, the Authority, keeping in view, the financial implication on NPL, has allowed interim adjustment as per NPL's request, subject to adjustment (if required) on the basis of revised or modified mechanism. The revised fuel cost component of NPL's tariff, applicable for the fuel procured during the month of December, 2009 is indicated hereunder;


