## DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR ORIENT POWER COMPANY (PVT.) LIMITED

Pursuant to the Paragraph 13 (iii) of the Authority's decision dated September 17, 2009 in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff of OPCL has been adjusted for variation in HSD prices. The revised energy charge part of OPCL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:

Note: Since the revised prices have been withdrawn by the Government of Pakistan, therefore the fuel cost component (Rs. 13.9483/kWh) on HSD determined for the month of December 2010 will be effective from 8<sup>th</sup> January 2011 till the time prices are revised.
