3. Please note that the schedule of revised Tariff to be notified in the official Gazette is attached as Annex-I.

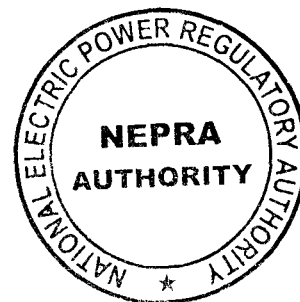


**DECISION OF THE AUTHORITY IN THE MATTER OF
FUEL PRICE ADJUSTMENT FOR ORIENT POWER COMPANY (PVT.) LIMITED**


