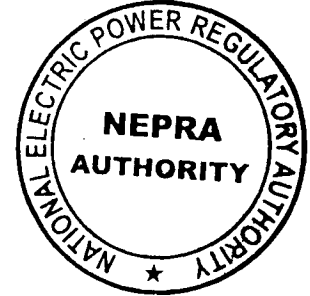


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR  
ORIENT POWER COMPANY (PVT.) LIMITED**


Pursuant to the Paragraph 13 (iii) c of the Authority's decision dated June 01, 2011 in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff of OPCL has been adjusted for variation in HSD prices. For stock purchased w.e.f. 1st December 2011	17.7661



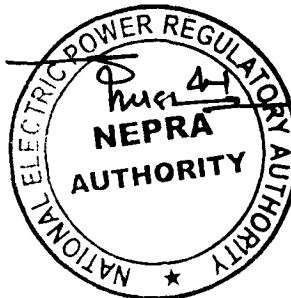
