CORRIGENDUM- DECISION OF THE AUTHORITY WITH RESPECT TO MOTION FOR LEAVE FOR REVIEW IN THE MATTER OF TARIFF ADJUSTMENT OF ORIENT POWER COMPANY LIMITED (OPCL) GENERATION TARIFF DATED JANUARY 12, 2012 CASE NO.NEPRA/TRF-124/OPCL-2009(2)

This is with reference to the decision of the Authority with respect to motion for leave for review filed by Orient Power Company Limited (OPCL) communicated vide letter No. NEPRA/Tariff-124/OPCL-2009/280 dated January 12, 2012. The Authority observed that at line-2, para 7.1 at page-3 the word appeared as "higher" instead of "lower". Similarly the figure of correction factor at line-4, para 7.3 at page-4 appeared as "209/212.7" instead of "212.7/209". The Authority considers that these typo errors needs to be rectified through corrigendum, therefore, following corrections have been made in the above-mentioned decision:

- a. The word "higher" be replaced with "lower: appearing at line-2, para 7.1 at page-3 and
- b. The figure of correction factor "209/212.7" be replaced with "212.7/209" appearing at line-4, para 7.3 at page-4;

NOTE OF MR. SHAUKAT ALI KUNDI IN THE MATTER OF RECONSIDERATION OF TYPOGRAPHICAL ERRORS IN THE DECISION OF THE MATTER OF MOTION FOR LEAVE FOR REVIEW FILED BY ORIENT POWER COMPANY LIMITED (OPCL)

The instant decision is a consequence of decision dated January 12, 2012 on Motion for Leave for Review filed by Orient Power Company Limited (OPCL) on April 25, 2011 which has been admitted by a quorum of 03 Members including the Chairman.

2. In my considered opinion, the admission of Motion for Leave for Review of OPCL and decision thereon is violative of Rule 16(6) of NEPRA (Tariff, Standards & Procedure Rules), 1998 ("the rules"), as Rule 16(6) of the Rules clearly provides that within 10 days of a service of final order, determined or decision of the Authority, a party may file a 'motion for leave for review' by <u>full strength of Authority</u> of such final order, determination or decision, as the case may be. At the time, when Motion for Leave for Review of OPCL was being considered and decided, the posted strength of the Authority (NEPRA) was 04 Members, including the Chairman, but the review was considered and decided by three Members including the Chairman in violation of relevant rules. Thus in my opinion the decision on "Motion for Leave for Review" filed by OPCL suffers from legal infirmity.

3. It may not be out of place to mention here that I had earlier objected to this admission of "Motion for Leave for Review" filed by OPCL vide my note No.NEPRA/ML/OPCL/2011-2669 of 16/12/2011, addressed to the Chairman and asked for its rectification (copy) enclosed. But, I am still unaware of the outcome.

4. Based on the foregoing, I still hold my earlier stand expressed in my aforestated note at 3 above.

Motion for Leave for Review of Orient Power Company Subject: Limited (OPCL)

Reference is made to letter No. NEPRA/TRF-124/OPCL-2009 (2) of 7/12/2011 of DG (Tariff) as per which, draft decision has been circulated for perusal of the Authority.

While going through the case file I have observed that the Motion for Leave for 2. Review of the subject power plant has been admitted in violation of Rule 16(6) of the NEPRA Tariff Standards and Procedure Rules, 1998, which reads as under:

. "Rule 16(6): Within ten days of service of a final order, determination or decision of the Authority, a party may file a motion for leave for review by the full strength of the Authority of such final order, determination or decision, as the case may be.

The Motion for Leave for Review of OPCL has been admitted by a quorum of 03 3. Members only whereas it was required to be heard and decided by the full strength of Authority under the relevant Rules. In my opinion, there is an anomaly in the admission of the subject matter therefore this need to be rectified before the decision on Motion for Leave for Review of OPCL is signed and would not stand the test of scrutiny if impugned at a higher forum/competent court of law.
