


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
ORIENT POWER COMPANY (PVT.) LIMITED**



For stock purchased w.e.f. 1 st February 2012	18.5998

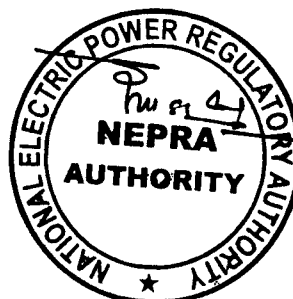
