## Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff of Orient Power Company (Pvt) Limited (OPCL)

Pursuant to Para 10(I) of the decision of the Authority dated 12<sup>th</sup> January 2012 in the matter of motion for Leave for review filed by OPCL against the decision of the Authority regarding adjustments in generation tariff at COD, on the basis of information provided by OPCL, the insurance component of capacity charge part of tariff of OPCL has been revised on the basis of actual insurance premium of Rs. 113.37 million net of 16% Federal Exise Duty of Rs. 17.40 million in accordance with the Schedule VIII of the Power Purchase Agreement (PPA).
