
**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
ORIENT POWER COMPANY (PVT) LIMITED**


Pursuant to the Paragraph 10(iii)(c) of the Authority's decision dated 12th January 2012 in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff of OPCL has been adjusted for variation in HSD prices. 

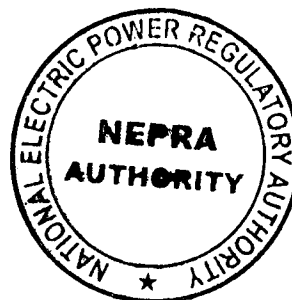


