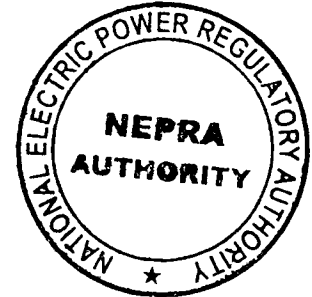

ORIENT POWER COMPANY (PVT.) LIMITED**


