

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT BASED ON
RLNG FOR ORIENT POWER COMPANY (PRIVATE) LIMITED**

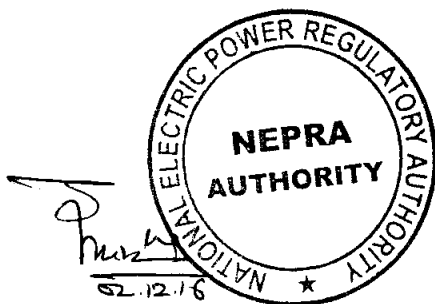
1. Pursuant to the Authority's decision dated 12th January 2012 and 3rd May 2016 in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff of OPCL has been adjusted for variation in RLNG price.
2. Pursuant to the Economic Coordination Committee (ECC) of the Cabinet decision dated June 14, 2016, Oil & Gas Regulatory Authority (OGRA) vide its determination dated October 07, 2016 has re-determined RLNG prices for the period April 2015-February 2016 and also determined RLNG prices for the period March 2016-June 2016.
3. Based on OGRA's RLNG price determination, the Authority has worked out the Fuel Cost Component of OPCL, indicated hereunder, which shall be immediately applicable on units delivered basis:





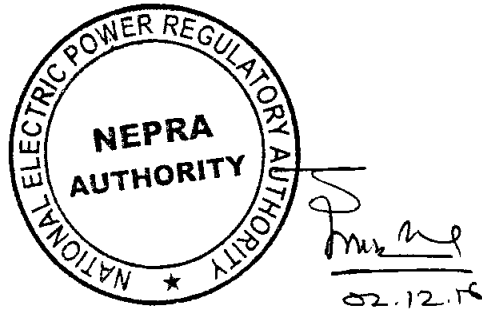
