

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
ORIENT POWER COMPANY (PRIVATE) LIMITED**

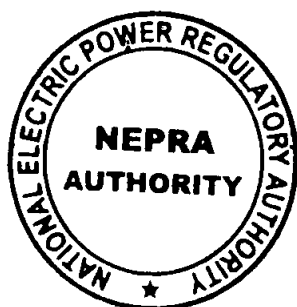
