


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR ORIENT  
POWER COMPANY (PRIVATE) LIMITED**


1. Pursuant to the Authority's decision dated 12th January 2012 and 3rd May 2016 in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff of OPCL is required to be adjusted for variation in RLNG price.
2. Oil & Gas Regulatory Authority (OGRA) vide its determination dated September 20, 2017 has re-determined final RLNG prices for the months of February and March, 2017. Based on OGRA's revised final RLNG price determination, OPCL requested for revision of the fuel cost component for the period of March 2017 and accordingly the fuel cost component has been revised. The revised fuel cost component on final RLNG price, indicated hereunder, shall be immediately applicable on unit delivered basis:




4. The above decision of the Authority shall supersede the previous decision issued in the matter vide No. NEPRA/TRF-124/OPCL-2009/14010-14 dated August 15, 2017. The revised fuel cost component of energy charge part of tariff attached as Annex-I is to be notified in the official gazette, in accordance with the provisions of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.



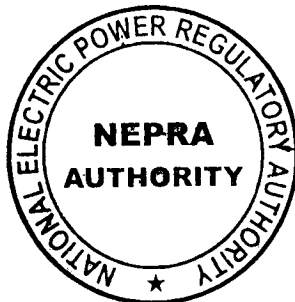


