## DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR ORIENT POWER COMPANY (PRIVATE) LIMITED

- 1. Pursuant to the Authority's decision dated 12<sup>th</sup> January 2012 and 3<sup>rd</sup> May 2016 in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff of OPCL is required to be adjusted for variation in RLNG price.
- 2. Oil & Gas Regulatory Authority (OGRA) vide its determination dated June 2, 2017 has determined final RLNG prices for the months of July 2016-December 2016.
- 3. Based on OGRA's final RLNG price determination, OPCL requested for revision of the fuel cost component for the month of November 2016. Accordingly the fuel cost component has been revised.
- 4. The revised fuel cost component on final RLNG price, indicated hereunder, shall be immediately applicable on unit delivered basis:

Month	Fuel Cost Component (Rs./kWh)
November 2016	6.4650

5. The above referred revised fuel cost component of energy charge part of tariff attached as **Annex-I** is to be notified in the official gazette, in accordance with the provisions of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
