


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR  
ORIENT POWER COMPANY (PRIVATE) LIMITED**

Pursuant to the Authority's decision dated 12<sup>th</sup> January 2012 notified vide S.R.O No. 295(I)/2012 dated 19<sup>th</sup> March 2012, in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff of OPCL has been adjusted for variation in HSD price. The revised energy charge part of OPCL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:


