Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff of Orient Power Company Limited (OPCL)

1. Pursuant to the decision of the Authority dated 12th January 2012 in the matter of Motion for Leave for review filed by OPCL against the decision of the Authority regarding adjustments in generation tariff at Commercial Operation Date (COD), on the basis of information provided by OPCL, the insurance component of capacity charge part of tariff of OPCL has been revised on the basis of actual insurance premium of **Rs.145,065,087/-** (net of Federal Exercise Duty (FED)) in accordance with the schedule VIII of the Power Purchase Agreement (PPA). The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable :

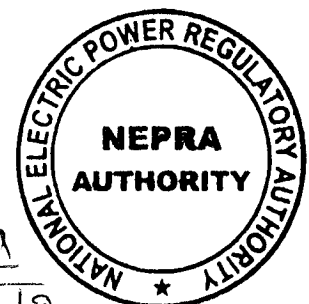
