

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR ORIENT
POWER COMPANY (PRIVATE) LIMITED**


1. Pursuant to the Authority's decision dated January 12, 2012 and May 3, 2016 in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff of OPCL is required to be adjusted for variation in fuel price.
2. Oil & Gas Regulatory Authority (OGRA) vide its decision dated July 15, 2020, has determined provisional RLNG weighted average price for SNGPL for the month of July 2020. Based on OGRA's notification, the fuel cost components on RLNG of OPCL have been revised. The revision has been made on provisional basis and final fuel cost components shall be made after notification of final RLNG price determined by OGRA and submission of fuel invoice(s) by OPCL.
3. The revised fuel cost components for the period of July 2020 are indicated hereunder and shall be immediately applicable on unit delivered basis:




4. In case, RLNG price is not changed or not determined by the OGRA for the next period/month, Fuel Cost Component effective from July 22, 2020 shall remain applicable.
5. The above referred revised fuel cost component of energy charge part of tariff attached as **Annex-I** is to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
6. CPPA(G) to ensure that all payments are consistent with the determinations.




