ADJUSTMENT ON HSD FOR ORIENT POWER COMPANY (PRIVATE) LIMITED**



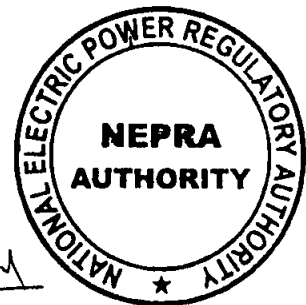
