

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE
ADJUSTMENT ON HSD FOR ORIENT POWER COMPANY (PRIVATE) LIMITED**

Pursuant to the Authority's decision dated January 12, 2012 notified vide S.R.O No. 295(I)/2012 dated March 19, 2012, in the case of Orient Power Company (Private) Limited (hereinafter "OPCL"), the fuel portion of energy charge part of tariff is required to be adjusted for variation of HSD price(s).
