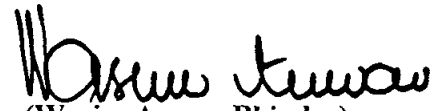

Please find enclosed herewith the subject Decision of the Authority alongwith **Annex-I** (total 02 pages) regarding adjustment in insurance component of capacity charge part of tariff of Orient Power Company Limited tariff on account of Actual Insurance Premium for the period of **May 24, 2026 to May 23, 2027** in Case No. NEPRA/TRF-124/OPCL-2009.

DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR THE PERIOD OF MAY 24, 2026 TO MAY 23, 2027 FOR ORIENT POWER COMPANY LIMITED (OPCL).

1. Pursuant to the decision of the Authority dated January 12, 2012 in the matter of Motion for Leave for review filed by Orient Power Company Limited (OPCL) against the decision of the Authority regarding adjustments in generation tariff at Commercial Operation Date (COD), the insurance component of tariff is subject to adjustment as per actual annually, with maximum of 1.35% of EPC cost, whichever is lower. OPCL requested to approve insurance component of Rs. 0.1241/kW/h for the period May 24, 2026 to May 23, 2027. OPCL in support of its request provided copies of insurance premium receipts and premium payment evidences. The details of requested insurance cost net of Federal Exercise Duty is as under:

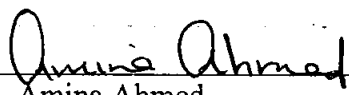

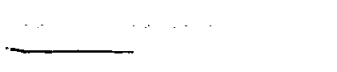
2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereinafter called as the decision of Authority in the matter:

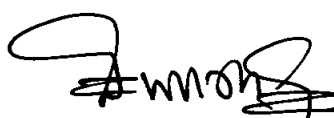
“Based on information and documentary evidence(s) provided by OPCL and in accordance with the schedule VIII of the Power Purchase Agreement, the insurance component of capacity charge part of tariff has been revised to Rs. 0.1241/kW/h for the coverage period of May 24, 2026 to May 23, 2027 on the basis of net insurance cost of Rs. 231,295,692.”

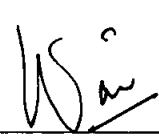
3. The above decision of the Authority along with revised tariff schedule attached as **Annex-I** are to be notified in the official Gazette, in accordance with the provisions of section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997).
