DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT ON HSD IN COMBINED CYCLE OPERATIONS FOR PUNJAB THERMAL (PRIVATE) LIMITED.

- 1. Pursuant to the Authority's decision dated December 26, 2017 in the matter of tariff petition filed by Punjab Thermal Power (Private) Limited (hereinafter "PTPL") and decision dated June 7, 2018 notified vide S.R.O. No. 1059(I0/2018 on August 27, 2018 in the matter of Motion for Leave for Review of PTPL, the fuel portion of energy charge part of tariff of PTPL is required to be adjusted for variation in fuel price(s).
- 2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of Authority in the matter:-

"Based on information and documentary evidence submitted by PTPL, the fuel cost component on HSD in combined cycle operations has been adjusted."

3. The revised fuel cost component is indicated hereunder and shall be immediately applicable on unit delivered basis for the respective periods:
