

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE
ADJUSTMENT ON SIMPLE CYCLE OPERATION ON RLNG FOR THE MONTH OF
MAY 2022 FOR PUNJAB THERMAL POWER (PRIVATE) LIMITED.**


1. Pursuant to the Authority's decision dated December 26, 2017 in the matter of tariff petition filed by Punjab Thermal Power (Private) Limited (hereinafter "PTPL") and decision dated June 7, 2018 notified vide S.R.O. No. 1059(I0/2018 on August 27, 2018 in the matter of Motion for Leave for Review of PTPL, the fuel portion of energy charge part of tariff of PTPL is required to be adjusted for variation in fuel price(s).
2. Oil & Gas Regulatory Authority (OGRA) vide its notification dated May 13, 2022 has determined provisional weighted average RLNG price of US\$ 20.0711/MMBTU for SNGPL for the month of May 2022. Based on OGRA's notification and Authority's decisions, the fuel cost components on simple cycle operation have been adjusted for variation in RLNG price(s). The revision has been made on provisional basis and final fuel cost components shall be made after notification(s) of final RLNG price(s) determined by OGRA and submission of fuel invoice(s) by PTPL.
3. The revised fuel cost components on simple cycle operation on RLNG indicated hereunder shall be immediately applicable on unit delivered basis:



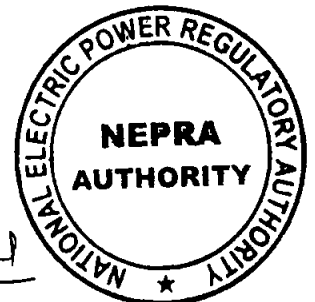

5. CPPA(G) to ensure that all payments are consistent with tariff determination(s).


