

ADJUSTMENT ON HSD FOR MARCH 21, 2022 FOR QUAID-E-AZAM

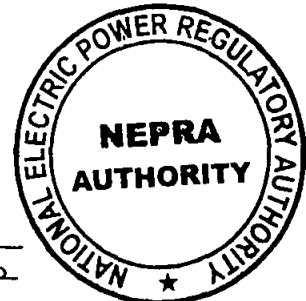
