ADJUSTMENT ON HSD FOR NOVEMBER 24, 2022 FOR QUAID-E-AZAM
THERMAL POWER (PRIVATE) LIMITED**

Pursuant to the Authority's decision dated 14th April 2016 in the matter of Tariff Petition filed by Quaid-e-Azam Thermal Power (Private) Limited (hereinafter "QATPL"), the fuel portion of energy charge part of tariff is required to be adjusted for variation of HSD price(s). 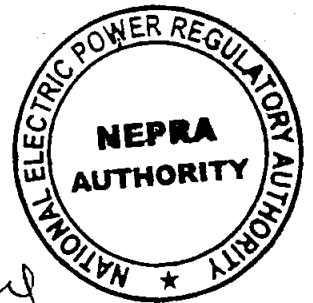

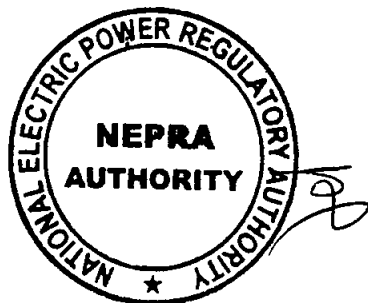
