DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT ON HSD FOR DECEMBER 6, 2022 FOR QUAID-E-AZAM THERMAL POWER (PRIVATE) LIMITED

Pursuant to the Authority's decision dated 14th April 2016 in the matter of Tariff Petition filled by Quaid-e-Azam Thermal Power (Private) Limited (hereinafter "QATPL"), the fuel portion of energy charge part of tariff is required to be adjusted for variation of HSD price(s). Based on revised HSD price of Rs.232.8237/litre, the fuel portion of energy charge part of tariff of QATPL has been adjusted and indicated hereunder which shall be immediately applicable on units delivered basis:


