DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT ON HSD FOR QUAID-E-AZAM THERMAL POWER (PRIVATE) LIMITED

- 1. Pursuant to the Authority's decision dated 3rd January 2023 notified vide S.R.O. No. 182(I)/2023 on February 14, 2023 in the matter of tariff adjustment at Commercial Operations Date adjustment for Quaid-e-Azam Thermal Power (Private) Limited (hereinafter "QATPL"), the fuel portion of energy charge part of tariff is required to be adjusted for variation of HSD price(s).
- 2. Accordingly, the fuel portion of energy charge part of tariff of QATPL on HSD has been revised and indicated hereunder which shall be immediately applicable on units delivered basis. The instant decision shall also supersede the previous decisions of the Authority mentioned below.
