DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT ON HSD FOR QUAID-E-AZAM THERMAL POWER (PRIVATE) LIMITED

- 1. Pursuant to the Authority's decision dated 3rd January 2023 notified vide S.R.O. No. 182(I)/2023 on February 14, 2023 in the matter of tariff adjustment at Commercial Operations Date adjustment for Quaid-e-Azam Thermal Power (Private) Limited (hereinafter "QATPL"), the fuel portion of energy charge part of tariff is required to be adjusted for variation of HSD price(s).
- 2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Based on information and documentary evidence submitted by QATPL, the fuel cost component on HSD has been revised."

3. The revised fuel cost component is indicated hereunder and shall be immediately applicable on unit delivered basis for the respective period:
