

DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR QUAID-E-AZAM THERMAL POWER (PRIVATE) LIMITED


Pursuant to the Authority's decision dated 14th April 2016 in the matter of Tariff Petition filed by Quaid-e-Azam Thermal Power (Private) Limited (hereinafter "QATPL"), the fuel cost components on simple cycle operation have been adjusted for variation in RLNG price. The revision has been made as per OGRA's notification of final RLNG price determination dated 20th June 2017. The revised fuel cost components on simple cycle operation on RLNG indicated hereunder shall be immediately applicable on units delivered basis:

Period	Revised Fuel Cost Component Rs./kWh
With Effect from 9 th -15 th March 2017	9.1602
With Effect from 16 th -23 rd March 2017	9.1611
With Effect from 24 th -31 st March 2017	9.1607


