

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR  
QUAID-E-AZAM THERMAL POWER (PRIVATE) LIMITED**

Pursuant to the Authority's decision dated 14<sup>th</sup> April 2016 in the matter of Tariff Petition filled by Quaid-e-Azam Thermal Power (Private) Limited (hereinafter "QATPL") for determination of Generation Tariff on RLNG/HSD, the fuel portion of energy charge part of tariff of QATPL has been adjusted for variation in HSD price. The revised energy charge part of QATP's tariff relating to plant testing indicated hereunder shall be immediately applicable on units delivered basis:
