DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR QUAID-E-AZAM THERMAL POWER PRIVATE LIMITED

Pursuant to the decision of the Authority dated April 14, 2016 in the matter of Generation Tariff for Quaid-e-Azam Thermal Power (Private) Limited (QATPL) on simple cycle operation, the fixed O&M, variable O&M and cost of working capital components of tariff in respect of July-September 2017 quarter have been revised on account of US CPI, CPI (General), exchange rate and KIBOR variation in accordance with the requisite indexation/adjustment mechanisms stipulated in the decision of the Authority. The revised tariff indicated hereunder shall be immediately applicable:
