


**DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY
INDEXATION/ADJUSTMENT OF TARIFF FOR RESHMA POWER GENERATION
PRIVATE LIMITED**

Pursuant to the decision of the Authority dated February 04, 2016 in the matter of application of Reshma Power Generation Private Limited for unconditional acceptance of Upfront tariff for utilization of existing available capacity short-term independent power producers, the fixed O&M, variable O&M and cost of Working capital components of tariff in respect of January-March 2018 quarter has been revised on account of CPI (General) and KIBOR variation in accordance with the requisite indexation/adjustment mechanisms stipulated in the decision of the authority. 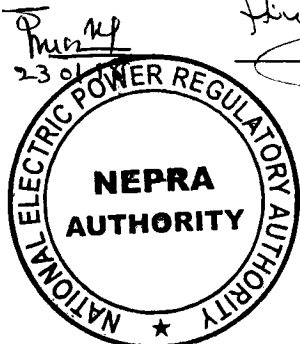

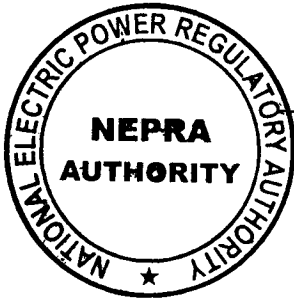
