Please find enclosed herewith the decision of the Authority along with schedule of tariff (Annex-I & II) (03 pages) regarding provisional adjustment in energy charge part of Saif Power Limited's tariff on account of variation in HSD prices with effect from 1st January 2011 and 7th January, 2011 in Case No. NEPRA/TRF-99/SPL-2008.

The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31 (4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.

INTERIM DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR SAIF POWER LIMITED

The Authority in its decision dated January 16, 2009 in the case of Saif Power Limited (hereinafter "SPL") provided a mechanism for adjustment of the fuel portion of energy charge part of tariff on HSD for variation in price of HSD as notified by the relevant Authority adjusted for NCV-GCV factor, specific gravity and calorific value (gross). In this regard the relevant extract of the decision of the Authority dated January 16, 2009 is reproduced as under:

"Para : In case of adjustment in HSD fuel component, SPL shall submit request for adjustment duly supported with the supplier's certificate indicating flash point, specific gravity and calorific value duly verified by the power purchaser. The Power Purchaser shall make all necessary arrangements to satisfy it regarding the Authenticity and validity of the information provided by SPL. In case of any dispute or discrepancy the power purchaser shall seek third party verification which for technical issues shall be HDIP and for price issues shall be OGRA."

SPL's instant adjustment request is not accompanied by supplier's certificate indicating flash point, specific gravity and calorific value duly verified by the power purchaser in accordance with the Authority's decision dated January 16, 2009. In view thereof, the Authority hereby directs SPL to fulfill all the requirements strictly in accordance with the above referred decision of the Authority. The Authority, however, is cognizant of the fact that rejection of the instant request of SPL for not being in accordance with the decision of the Authority has financial implications. The Authority, therefore, keeping in view the financial implications has decided to allow fuel price adjustment without considering the impact of variation in calorific value as an interim arrangement. The Authority shall pass its decision once the required information is submitted by SPL strictly in accordance with the Authority's decision dated January 16, 2009. Based on the interim arrangement as afore-referred, revised energy charge part of SPL's tariff relating to HSD indicated hereunder shall be immediately applicable on units delivered basis:

The above referred revised fuel cost components attached as Annex-I & II to this decision are to be notified in the official gazette, in accordance with the provisions of sub-section (4) of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
