

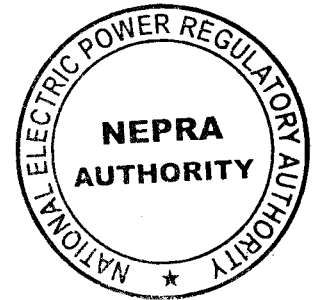
3. Please note that only revised schedule (Annex-I) of tariff is required to be notified in the official Gazette.


**DECISION OF THE AUTHORITY IN THE MATTER OF
FUEL PRICE ADJUSTMENT FOR SAIF POWER LIMITED**


