FINAL DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR THE MONTH OF DECEMBER 2010 FOR SAIF POWER LIMITED

Pursuant to the Authority's decision dated January 16, 2009, the fuel cost component of the energy charge part of the tariff of Saif Power Limited (hereinafter "SPL") is subject to adjustment on the basis of variation in HSD price, calorific value and specific gravity which must be supported with the supplier's certificate indicating flash point, specific gravity and calorific value duly verified by the power purchaser.

SPL vide its letter No. NEPRA/10/072 dated 15th December 2010 submitted its request for adjustment in its fuel cost component w.e.f. 1st December 2010 on account of HSD price variation as notified by Shell. SPL provided test reports regarding calorific value of 18,760 Btu/lb. and specific gravity of 0.8388 from Hydrocarbon Institute of Pakistan (HDIP) which were not verified by the power purchaser. The Authority vide its decision dated 31st December 2010 allowed adjustment in fuel cost component subject to the condition that the fuel cost component will be revised in case the power purchaser verified different calorific value and specific gravity. SPL vide its letter No. NEPRA/11/014 dated 4th April 2011 & letter No. NEPRA/11/015 dated 19th April 2011 withdrew its claim for adjustment of calorific value and requested downward revision in fuel cost component from Rs. 14.5289/kWh to Rs. 14.0117/kWh. The Authority has decided to adopt the tested calorific value of 19,430 Btu/lb. (42,891.73 Btu/Kg.) as submitted by SPL. The Authority directs the power purchaser to adjust the excess amount received by SPL in the subsequent billing. Accordingly the fuel portion of energy charge part of SPL's tariff has been revised which shall be applicable to the units delivered during the month of December 2010:

The above referred revised fuel cost component attached as (Annex-I) is to be notified in the official gazette, in accordance with the provisions of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997 which shall substitute the earlier decision dated December 31, 2010.
