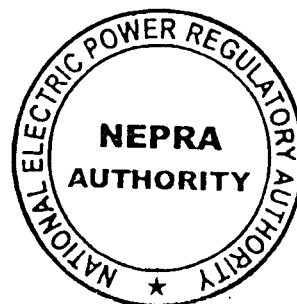
3. Please note that only revised schedule (Annex-I) of tariff is required to be notified in the official Gazette.


Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff of Saif Power Limited (SPL)


